Equipment and machinery demonstrations are encouraged at Forestry Expo 2019 but are restricted to the blocks of stands shown on the event layout plan. These stands will be located in the Trade Stands field which has a grass surface.

It is not possible to cut standing timber or demonstrate within the harvesting site due to space limitations, however, there is a desire to expand such opportunities at future Forestry Expo events in 2021 and beyond.

Demonstrations in the Trade Stands field will be restricted to specific times during the day. A timetable of demonstrations will be agreed with exhibitors and printed in the Event Catalogue so that visitors can plan their day accordingly.

If you wish to demonstrate at Forestry Expo, please select a suitable stand size to incorporate your demonstration, a block preference as listed on the plan and state what machines / equipment you wish to demonstrate.

Timber, wood chips, chipwood etc. can be ordered for use on your stand. Please complete the appropriate section of the application form. Exhibitors who wish to demonstrate are required to pay a £200 deposit to cover any potential restitution costs. This will be fully refunded on completion of the event once the stand has been cleared to the approval of Forestry Expo organisers

Timber

Timber including bars, wood chips, chipwood etc to be used as part of a demonstration can be purchased from Forestry Expo. Timber can also be obtained for display and dressing of stands.

Exhibitors are not permitted to bring their own timber on to site.

To order timber please complete the appropriate section on the application form: prices will be confirmed nearer the event.

Terms and Conditions

1. Health and Safety

Stand/demonstration areas must be must be clear of visitors before demonstrations start. Visitors must be kept at a safe distance from any working machinery by suitable means. Crowd control barriers can be supplied by Forestry Expo. Please get in touch with the organisers for more information. Exhibitors undertake demonstrations at their own risk and must comply with all the relevant safety guidelines and equipment manuals. The exhibitor named on the application will be responsible for the demonstration unless Forestry Expo are informed otherwise. All exhibitors must comply with Forestry Expo Officials and the organisers reserve the right to stop any demonstrations on safety grounds. The use of chemicals is strictly forbidden.

2. Demonstrating Equipment

All machinery and equipment must comply with all current health and safety requirements and carry the relevant CE marking or equivalent. All equipment must be used according to the user manual and by suitable qualified persons wearing the appropriate PPE. Any relevant documentation must be available for inspection. Machines producing sawdust, woodchip etc. must not direct the discharge towards spectators. The appropriate warning signage must be placed on the perimeter of the demonstration safety zone.

3. Timber Stacks

Exhibitors must ensure that all timber stacks are stable and do not exceed a height of 2 metres. Where possible stacked timer must be inaccessible to visitors. Visitors must not be allowed to climb on stacked timber. Warning signage must be placed around the perimeter of the stacks.



LAYOUT

Forestry Expo Scotland offers a layout designed to facilitate visitor flow and provides exhibitors with flexibility in stand size and location options.

DEMONSTRATIONS

Demonstrations stands are available in blocks 2, 3, 4 & 5.

HEIGHT RESTRICTION

There is a 5.3m height restriction for access to the site.
